## 2018/2019 Membership Subscription Form

### TAX INVOICE

GPA Membership fees are made up of two parts:

1. A **membership application fee** of \$50.00 plus GST.
2. An **annual subscription** linked to the gross value of production (GVP) of each member.

2018/2019 subscriptions are calculated as a function of gross value of production for the 12 months to 30 June 2018. The 2018/2019 subscription is 0.035% of gross farm gate value of production, with a \$50 minimum. For example, for \$200,000 of GVP a member will pay \$70.00 of subscription plus GST.

The amount of subscription fees paid by each member will be used to determine each member's voting entitlements.
